**Inviting applications for Appointment of the Member for the  
"Real Estate Appellate Tribunal, Punjab"**

The selection committee constituted under the provisions of Section 46(3) of the Real Estate (Regulation and Development) Act, 2016 invites applications from the eligible candidates for the appointment of **one whole time Member (Technical/Administrative)** of the Real Estate Appellate Tribunal, Punjab.

The candidate should have well-versed in the field of urban development, housing, real estate development, infrastructure, economics, planning, law, commerce, accountancy, industry, management, public affairs or administration and possesses experience of at least twenty years in the field or who has held the post in the Central Government, or a State Government equivalent to the post of Additional Secretary to the Government of India or an equivalent post in the Central Government or an equivalent post in the State Government.

The Member shall hold office for a term not exceeding five years from the date on which they enter upon their office, or until attaining the age of sixty five years, whichever is earlier and shall not be eligible for re-appointment.

The Salary and allowances payable and other terms and conditions shall be as per the Punjab State Real Estate (Regulation and Development) Rules, 2017 and notification and guidelines issued by Government from time to time.
