RULES

- 1. (1) These rules may be called the Delimitation of Wards of Municipalities (First Amendment) Rules, 2022.
 - (2) They shall come into force on and with effect from the date of their publication in the official Gazette.
- 2. In the Delimitation of Wards of Municipalities Rules, 1972, in rule 3, in sub-rule (1), for clause (iii) and the entries relating thereto, the following shall be substituted, namely:-
 - "(iii) Additional Deputy Commissioner (Urban Development);".

RULES

- 1. (1) These rules may be called the Punjab State Real Estate (Regulation and Development) (First Amendment) Rules, 2022.

- 2. In the Punjab State Real Estate (Regulation and Development) Rules, 2017, in the Schedule, for the existing headings and entries mentioned thereunder
